Scope of Work:

Install a wheelchair ramp that is and will remain the property of Sardis United Methodist Church, Sardis,MS(hereinafter called SUMC) allowing access by the wheelchair user listed above to the home located at the address listed above.

Definitions:

The "Homeowner" named on this form is the property owner where the ramp is to be installed. In the usage of this form, the "Homeowner" IS NOT the landlord of the property; the "Homeowner" is a resident of the property. The "Responsible Person" shall be a person, other than the wheelchair user, who is responsible for the ramp (See "Conditions").

Conditions:

This ramp remains the property of SUMC. The Responsible Person understands and grants access to the above listed property to install the ramp. The Responsible Person understands and grants access to the above listed property to remove the ramp at the conclusion of a term of no more than needed. The term of this agreement may be extended/renewed with the completion of a new agreement. SUMC reserves the right to bill the Responsible Person for the total replacement cost if the ramp is removed or sold by anyone other than representatives of SUMC. SUMC reserves the right to bill the Responsible Person for repair cost if the ramp is damaged prior to being removed from the site. The Responsible Person will contact SUMC at 662-209-1034 when the ramp is no longer needed or requires repair.

Liability Waiver

I understand that these are volunteers, not professionals working for profit, and that no warranty is made as to the quality of the work done. In consideration of volunteer goods and services to be rendered to me or on the property by the volunteers, I hereby release, acquit, forever discharge and agree to hold harmless the individual volunteers, SUMC, and any related agency from any and all liability for damages of any nature, including personal injury and property damages, expenses, delay or irregularity related in any way or arising out of my voluntary participation in this program or arising out of the goods and services provided by said program.

This release covers all rights and causes of action of any kind, nature, and description, which the undersigned had, or has, or but for this release, may have. This release binds the undersigned and his or her heirs, representatives, and assignees.
